

RDA Brakes Promotion 2021 FULL TERMS & CONDITIONS

1. The ("Promotor") is RDA Brakes (A division of GPC Asia Pacific Pty Ltd (ABN 97 097 993 283) of 34-36 Fiveways Boulevard Keysborough 3173, VIC and the ("Administrator") is BHSS-TBS Automotive Engineers, 4/2-10 Hallam South Road, Hallam VIC 3803 (ABN 64 133 889 451).
2. The (Promotion) commences at 8:00am AEST on 01/07/2021 and closes 5:00pm AEST on 31/08/2021 ("Promotional Period").
3. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed as acceptance of these Terms and Conditions.
4. This Competition is only open to BHSS-TBS Automotive Engineers customers aged 18 years or older.
