

RDA Brakes Promotion 2021 FULL TERMS & CONDITIONS

1. The ("Promotor") is RDA Brakes (A division of GPC Asia Pacific Pty Ltd (ABN 97 097 993 283) of 34-36 Fiveways Boulevard Keysborough 3173, VIC and the ("Administrator") is Gambier West Brake Service, 324C Commercial Street, West Mt Gambier SA 5290 (ABN 62 007 686 571).
2. The (Promotion) commences at 8:00am AEST on 01/06/2021 and closes 5:00pm AEST on 31/07/2021 ("Promotional Period").
3. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed as acceptance of these Terms and Conditions.
4. This Competition is only open to Gambier West Brakes Customers aged 18 years or older.
5. Employees (and their immediate families) of the Promoter, participating retail stores and agencies associated with this promotion are ineligible to enter.
